### OFFICIAL RULES

These are the official rules for the “College Gear Giveaway” presented by OnTheHub and Corel Corporation. This promotion will be referred to as the "Giveaway" throughout the rest of these rules. In these rules, "we", "our", and "us" refer to OnTheHub (as part of Kivuto Solutions Inc.) and Corel Corporation who, together, are the sponsors of the Giveaway (the “Sponsors”). "You" refers to a potentially eligible Giveaway’s entrant.

#### Giveaway Period

The Giveaway is run by OnTheHub and will take place in any state in the continental United States excluding Rhode Island, The United Kingdom and in any province in Canada excluding Quebec, from 08:00 ET September 1st, 2021, to 23:59:59 ET September 30th, 2021 (the “Giveaway Period”). This Giveaway is void where prohibited.

#### Giveaway Sponsors

For the purposes of the Giveaway, the “Giveaway Group” is composed of the Sponsors together with their affiliates, including without limitation their parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstake, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Giveaway and their respective employees, agents, and representatives (collectively, the “Giveaway Sponsor(s)”). #### Eligibility

The Giveaway is open to students, faculty, and staff (academic members) who: (i) reside in any state or territory within the continental United States excluding Rhode Island, The United Kingdom, or in any province or territory within Canada excluding Quebec; (ii) have reached the age of majority in the state, province, or territory in which they reside, as of the date of entering the Giveaway; (iii) have read and accepted the Official Giveaway Rules.

## How to Enter

To enter the Giveaway, users will have four options.

Option No. 1: Buy Corel software. (50 Entries)

Buy any piece of Corel software from OnTheHub, visit the promotion website (<https://onthehub.com/college-gear-giveaway>) and enter the purchase information using the widget located on the page. Purchase information includes name, last name, birth date, phone number, full address, school associated email address and the order confirmation number. The Sweepstake is limited to one (1) email address per IP address person. Only one email address must be used through the duration of the Giveaway; failure to do so will lead in disqualification.

Option No. 2: Refer the contest to your friends. (5 Entries)

You can use one of the following tools to complete a referral: Email, Facebook, Twitter, Tumblr, LinkedIn, and Messenger.

Option No. 3: Retweet the contest on Twitter. (5 Entries)

Option No. 4: No Purchase Necessary.

Individuals may receive one (1) entry for the Giveaway by legibly printing the contest week, entrant's name, and complete email address on a 3 x 5 inch (or 7.5 x 12.5 cm) piece of paper and mailing it to Kivuto Solutions Inc., 126 York Street, Suite 200, Ottawa, ON, K1N 5T5 Canada. Mail-in entries that omit this information will not be valid. All mail-in entries must be postmarked by September 1st, 2021 and received by September 30th, 2021.

All entries accumulated during the promotion period will be entered into the draw. This Giveaway is created for students, faculty, and academic staff only.

## Awarding of Prize

Three (3) winners will be randomly selected via an auto generator on Friday October 1<sup>st</sup>, 2021 at 01:00 PM ET. The winners will be notified via email and follow-up via phone.

To be declared a winner, a selected entrant must, in addition to meeting the Giveaway eligibility criteria and otherwise complying with the Official Giveaway Rules:

a) **For All Entrants:** Be reached by email by Kivuto or its representatives within ten (10) days immediately following the selection of the entry; b) Sign up for [the OnTheHub eStore](#) (it's free) to verify your academic status; c) Sign the Sponsors' Declaration and Release Form, which must include a witness's signature (a witness is a person of your choice who must be 18 years of age or older), by completing and returning it to Kivuto or its representatives at the address indicated on the Declaration and Release Form within five (5) days following its delivery by Kivuto or its representatives.

**Disqualification:** If any one of the conditions mentioned above is not met, the selected entrant will be disqualified and shall not be entitled to receive any prize, and the Sponsors reserve the right, in their sole and absolute discretion, to select at random another eligible entrant as a potential prize winner.

b) **For Canadian Residents (excluding residents of Quebec), in addition to (a) above:** Entrants selected to be awarded a prize must successfully answer a skill-testing question.
